

How to Request Contacts from the Department of Veterans Affairs

You will need to collect all the zip codes that are in your congressional district and send it along with your written request to the VA office. The request must be on the member's office stationary. The steps are outlined below along with sample language.

Locating the Zip Codes on HouseNet

1. Click <u>here</u> to start the process in HouseNet. Scroll to the bottom of your screen and select Search by District, enter the state abbreviation and district number and select Search.

Requesting a RONA from a House Liaison Representative

1. Construct your written request.

Note that any RONA requests must contain a) the veteran category (specifying the months and years for names and addresses of any recently discharged, if possible), b) proof of being a governmental body, c) a statement acknowledging penalties for unauthorized access to or usage of the data, d) a statement of the purpose of the RONA and the resources the organization proposes to devote to the purpose, and e) the contact information for someone in the office in case technical questions arise. *An example of a RONA request is located on the next page.

4. Print or Attach the saved Excel file of desired zip codes to your RONA request and send.

Dear Mr. Armstrong:

I am informed that the Department of Veterans Affairs has the capacity to provide the names and addresses of Veterans' in its discharge system, compensation, and pension files and education files in my congressional district. I would like to keep the Veterans in my district informed about legislation and benefits that directly affect them. I would greatly appreciate it if you would provide me with these names and addresses.

I am making this request in my official capacity as a Member of the United States House of Representatives, and I am aware that the confidentiality of these Veterans names and addresses is protected by Title 38, United States Code and the Privacy Act:. Accordingly, I will maintain this confidentiality, and confine my communications to areas of legislation and benefit changes that affect Veterans. Please be assured that my staff and I are aware that our use of Veterans names and addresses must remain limited to the reporting on legislation and changes in benefits and/or entitlement programs. We also understand that a willful use of the names and addresses for purposes other than those specified shall be construed as a misdemeanor and render my staff and me subject the penalties noted in Section 5701(F).

I am enclosing the zip codes in my district to aid you in compiling the list and to facilitate responding to my request. I wish to receive this listing in the form of a Comma Separated Value (CSV) file.
